Rick called the meeting to order at 5:30PM and introduced those present. Jerry read the ground rules for conducting the meeting.

Steve made a motion to approve the minutes of 5/6 meeting, seconded by Jerry and passed on a voice vote.

Appearances by local citizens/visitors – Steve Edgerley stated that he spoke with Vince Buttice regarding Terry Dugan – Vince and Steve have been in contact with one of Terry's relatives.

Water/Sewer/Solar Panel Report – Josh and Meagan discussed the asset management plan. Mike stated he spoke with Jason Booth at A & E regarding HSA#1 and we are all on the same page. Lyle Curtis would like to hook onto the water and sewer for his lot on the Cross Road. The board saw no problem with this as long as Mike Baraw was there to oversee this. Mike stated that we had our sewer inspection and all went well. We have not seen the report yet.

Road Commissioner Report – Mike stated that a lot of time has been spent working on equipment. The Lake Road has been graveled and is almost ready for asphalt. Mike stated we should know within a couple weeks about the paving grant we may get. We have received a grant for the Farrar Road. Gail Demers has talked to Mike about an issue with her lawn eroding into the pond – she feels that the town should fix this. Mike feels this is not affecting our road at all. The board agrees with Mike that we cannot work outside of our ROW.

Charles Guadagni stated there are drainage issues at the Lake Road Cemetery. Mike Baraw has gone over and taken a look at it as well. The cemetery commission would like permission to put this out to bid for repair. The board asked Denise to put this in the paper for bid.

Steve made a motion to accept Nick Smith resignation as lister and zoning administrator effective July 31, 2021, seconded by Jerry and passed on a voice vote.

Yard Sale update – Denise stated that this is not going to happen – the people interested in doing this are no longer interested.

Jerry made a motion to adopt the updated Local Emergency Management Plan, seconded by Rick and passed on a voice vote.

The board signed orders, reviewed and approved the bank statement and journal entries, signed Ryan, Robinson, and Schendorf cemetery deeds.
