Steve called the meeting to order at 5:30PM and introduced those present. Rick read the ground rules for the meeting.

Steve made a motion to award the 2023 lawn care bids to Knight property management, seconded by Jerry. Some discussion followed. This passed on a voice vote.

Steve made a motion to appoint Dave Ghelli and Wendy Matthews to the NEK Broadband board for 2023, seconded by Jerry and passed on a voice vote.

Jerry made a motion to approve liquor licenses for 2023 to Glover's Family Market and Hilliker's Store, seconded by Rick and passed on a voice vote.

Steve made a motion to approve the orders, bank statement, and journal entries seconded by Rick and passed on a voice vote.

Unfinished/new business – Steve stated that we had put money in the budget for a greeter at the boat launch on Strawberry Acres. Tom Latta, who is heading this up, would like to know if the board would like to put an ad in the paper to see if anyone would be interesed in this position. The board asked Denise to place and ad in the paper to see if anyone would be interested. This will be on the May agenda for further discussion. Jerry stated that he and Rick were at the annual meeting with VTRANS, along with Mike and Denise, and all went well. Voted to adjourn at 6:05PM.
